Name of Product/Version: ProQuest ETD Administrator

Product description: ETD Administrator is a web-based application ProQuest provides for free to institutions who publish their Master's or Doctoral graduate works with ProQuest. The application accommodates workflows and tasks for several audiences:

- **Student authors** use ETD Administrator to submit their work to a site administrator at their institution. Representative tasks in the submission process include entering required personal information, uploading a PDF of the manuscript along with any supplemental files, choosing whether they want their work freely available on the web, and ordering print copies of their work.
- **Site administrators** review student submissions, checking the uploaded PDF for adherence to institutional formatting and stylistic standards. Administrators also use the application to manage the workflow of all graduate works. Workflow tasks can include creating additional administrators, assigning submissions to individual administrators for review, delivering approved submissions to ProQuest for editorial preparation and publishing to the ProQuest Platform.
- **Committee-review members and advisors** at select institutions can use ETD Administrator to review submission metadata (including version dates), ensuring that the submission PDF currently uploaded to ETD Administrator is the same version the committee approved at the conclusion of the defense process.
